GENERAL INFORMATION

DISPATCH SPRAYABLE improves the infiltration and penetration of applied irrigation water and rainfall and can be applied to all fine turf. DISPATCH SPRAYABLE is formulated to be applied by conventional spray rig equipment. For injection through irrigation systems, use DISPATCH INJECTABLE.

DIRECTIONS FOR USE

TURF
Turfgrass grown on soils such as those found on golf courses and athletic fields.

Application Rates and Frequency Options

- Spray 8 ounces per acre (0.58 liters per hectare) once a week
- Spray 16 ounces per acre (1.16 liters per hectare) every two weeks
- Spray 24 ounces per acre (1.75 liters per hectare) every three weeks

DISPATCH SPRAYABLE DOES NOT NEED TO BE WATERED-IN FOLLOWING APPLICATION.
Irrigate before next mowing or leave baskets off.

Tank Mixing Rate

For one time application with soil directed chemicals, apply 16 ounces per acre (1.16 liters per hectare). DISPATCH SPRAYABLE is compatible with most turf chemicals. Prior to application, evaluate the tank mix for compatibility and apply to a small area to determine the effect on turf quality.

STORAGE AND DISPOSAL

- Keep container tightly closed. Store in original container only. Keep in a secure and locked storage area. Do not add water to the contents of this container.
- Triple rinse container, empty rinse water into spray or stock tank. Dispose of empty containers in accordance with federal, state, and local law.
