GENERAL INFORMATION

InfilTRx improves the infiltration and penetration of applied irrigation water. This formulation can be applied to all fine turf species. InfilTRx may be applied through irrigation systems or by conventional spray rig equipment.

DIRECTIONS FOR USE

TURF Injection
Inject 24-32 fl oz per acre (1.8-2.3 L per hectare). Apply monthly or as needed throughout the growing season. For more difficult areas, InfilTRx may be applied at up to 3 pts (48 fl oz) per acre.

Conventional Sprayers
Apply InfilTRx at 3/4-1 fl oz/1000 sq ft in at least 1 gal of water (24-32 mL/4 L water/100 m²). Follow normal irrigation schedule. Apply monthly or as needed throughout the growing season. InfilTRx DOES NOT NEED TO BE WATERED-IN FOLLOWING APPLICATION. Irrigate before next mowing or leave baskets off.

Tank Mixing
Tank mix InfilTRx at 24-32 fl oz/100 gal of spray solution (190-250 mL per 100 L of spray solution). InfilTRx is compatible with most chemicals. Prior to application, evaluate the tank mix for compatibility and apply to a small area to determine the effect on turf quality.

STORAGE AND DISPOSAL

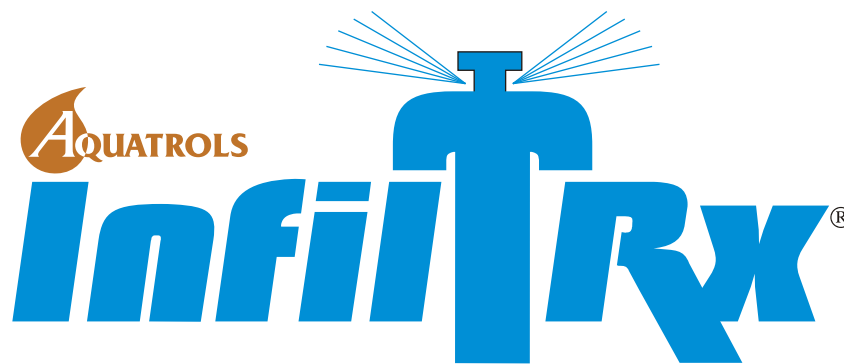
- Keep container tightly closed. Store in original container only. Keep in a secure and locked storage area. Do not add water to the contents of this container.
